

The Northeastern Society of Periodontists remains dedicated to advancing the expertise of professionals in periodontics and implants, fostering camaraderie and networking among colleagues. We extend our gratitude to Dr. Michael Chau, the 2024 program chair, for curating these exceptional programs. The NESP continues to be your premier resource for continuing education.

**DR. FRANK CELENZA** will present *Ortho/Perio in the Aligner Age*. Certain orthodontic movements are utilized for their beneficial impact upon the periodontium. These movements include forced eruption, molar uprighting, embrasure management, root torquing, and implant interactions. Historically, these movements were accomplished primarily by employing fixed appliance mechanotherapy. However, the advent and development of aligner therapy has developed to a level of sophistication that now allows these movements to be accomplished utilizing removable aligner techniques. This presentation will delineate the philosophy behind these movements, the periodontal benefit, and display clinical cases that illustrate these methods.

### LEARNING OBJECTIVES:

At the end of this course, clinicians will:

- develop an appreciation for the periodontal aspects of certain tooth movements;
- develop an appreciation for physiology of tooth movement;
- gain an understanding of aligner mechanotherapy;
- gain an exposure to interdisciplinary management of clinical situations.

Dr. Celenza is a second-generation dentist. His father, by the same name, was an internationally acclaimed teacher, author, and speaker in the field of prosthodontics. Dr. Celenza Jr. is dual-certified in the specialties of orthodontics and periodontics, an unusual and distinctive set of credentials. This dual specialty uniquely positions him to a deeper appreciation and understanding of the adult dentition, from treatment planning right through to treatment execution. He has been involved in postgraduate teaching for over 20 years at institutions such as New York University, and currently at Rutgers, New Jersey. He is widely published in the dental literature and has written six textbook chapters. He is an acclaimed speaker at major dental conferences both domestically and internationally. Dr. Celenza has

pioneered techniques and innovations in his field, and his work combining implant dentistry with orthodontics was ground-breaking. Outside of dentistry, Dr. Celenza is passionate about motor sports (a 2011 and 2012 national champion), cycling, and bass guitar. He was raised on Long Island, New York, currently resides in New Jersey and has 3 children. Dr. Celenza has offices in New York City and Westchester County, New York.

**DR. VINCENT CELENZA** will present *Are Implants Better Than Teeth?* Since the advent of osseointegrated implant fixtures in the early '80s from P.I. Branemark's famous work to now, the use of implants in everyday dentistry has grown dramatically. Not a day goes by in my office that I don't do something utilizing this technology when treating my patients. But is it always the best choice? Is it best to replace a missing tooth or teeth? Are there disadvantages? This presentation will not be a "how to" course in the placement of implants. It is intended to be a discussion to develop thought patterns about when decisions to use implants are made and why. What are their superior offerings in a given situation and should we venture to restore teeth instead? Additionally, and maybe more importantly, we want to ask these questions: Are these teeth restorable? Would restoring be better? What's involved and would restoring be a heroic venture? Would that be reckless? What are my own limitations and abilities and what about my patients' participation in this process? At the end of this presentation I hope there will be a slightly different view about when, where, and how to best employ the use of implants in our dental practices as an adjunct to prosthetic treatment when restoration of teeth has been ruled out.

### LEARNING OBJECTIVES:

- be able to put the use of dental implants into perspective;
- appreciate the long-term ramifications of dental implant restorations;
- gain an appreciation for prosthetic considerations necessary to restore implants.

Dr. Celenza is a Diplomate of the American Board of Prosthodontics, past president of the American Academy of Esthetic Dentistry, a fellow and past president of the Northeastern Gnathological Society [now renamed NGS Academy of Multidisciplinary Dentistry (NGS AMD)]. He is a Fellow of the Greater New York Academy of Prosthodontics and a Fellow of the American College of Prosthodontics. He has a private practice in Manhattan and is a regular presenter at NYU, Columbia, and the Manhattan VA.

**DR. GUSTAVO GIORDANI** will present *Digital Interdisciplinary Treatment - How to combine Biology with Technology to Achieve Predictability in The Aesthetic Zone*. In this new world that we live in, joining specialties combined with fast procedures has become something fundamental for the success of aesthetic rehabilitation. When we are faced with an interdisciplinary case involving cosmetic surgery, the use of digital planning for a correct and fast-guided execution, combined with prosthetic rehabilitation, offers the patient and staff a more predictable, quick, and less invasive treatment, seeking dentistry planned and non-reactive results. During the course, we will show how to work with a fast and predictable digital workflow combining implants, surgical periodontics, and aesthetic rehabilitation.

#### **LEARNING OBJECTIVES:**

At the end of this course, clinicians will understand:

- immediate implants in the aesthetic zone;
- guided surgery in perio plastic surgeries and implants;
- tissue management around natural teeth and implants;
- abutment design and soft tissue support;
- connective tissue - donor and receiving areas;
- aesthetic sutures;
- aesthetic crown-lengthening;
- tunneling procedures for soft tissue grafts;
- combination of surgery, orthodontics, and restorative treatments.

Dr. Giordani is a specialist in oral maxillofacial surgery and traumatology, with a postgraduate degree in implantology and periodontics. He specialized in cosmetic surgery at a Fellowship in Belgium with Dr. Eric Van Dooren. Dr. Giordani is author of the book *Interdisciplinary Aesthetic Dentistry The Big Picture* and several national and international scientific articles. He works as a clinician in his private clinic in São Paulo Brazil and works in partnership with the biggest names in aesthetic rehabilitation in Brazil and world. He stands out as an international speaker, participating in the biggest events of aesthetic dentistry surgery. ■

### *Demystifying NESP's Continuing Education Content*

At these board meetings, the program chair provides a brief overview of the title and presenters. The BOD then votes on whether to accept the speaker and their program based on the speaker's past performances, which must have been positively reviewed (scouted) at other meetings by at least one of our BOD or program committee or advisory committee members. Some key

points to our choices in CE are clinicians who present clinical techniques that will benefit our members immediately in private practice. These reproducible methods should be shared in a step-by-step fashion, instead of photos of before and miraculously after. New technologies and elucidating new scientific discoveries are an important part of the equation. Being evidence based is valuable. Delving into developing expert diagnosing skills, reviewing risks, and showing how to manage unexpected results are welcome. Controversial topics are also enticing, and point/counterpoint displays have had pivotal past success.

The lecturer prospers by having superb qualities of charisma while speaking with clarity and possessing considerable communication skills. Stunning productions, i.e., slide shows, should be artistic and visually engaging as well as easy to hear, see, and understand, and typically include video, audio, and animation.
